

Jenine C. Parchmon Senior Vice President Comerica Bank | LIBOR Transition Program Office

Jenine C. Parchmon is the Senior Vice President and program manager for the LIBOR Transition Program Office. Ms. Parchmon is responsible for helping to lead a large enterprise-wide effort focused on transitioning to alternative benchmark rates for a variety of products.

Prior to beginning her current role in July 2019, she was director of the Technology Strategy, Planning and Innovation group at Comerica Bank with responsibility for ensuring the successful delivery of strategic initiatives across the Technology organization and advancing overall innovation capabilities. She was also the interim Domain CIO for the Electronic Payments and Strategy Development domain from July 2018 to July 2019. In this role, she had responsibility for product delivery, business partner relationship management and operational support for key electronic payments applications, including the wire platform.

Immediately prior to moving back into a technology focused role, she was a Vice President in the Strategic Services Group at Comerica Bank, in Auburn Hills, Mich. Ms. Parchmon held this role for four years and had responsibility for managing the strategy development and execution for Comerica's internal services organization. She also had responsibility for leading and supporting key strategic initiatives across the enterprise.

She previously was a Vice President in the Enterprise Payments Strategy Group at Comerica Bank, in Auburn Hills, Mich. Holding this position for two years, she was responsible for leading the strategy development and execution for Comerica's Enterprise Payments Architecture program. A 2012 graduate of Comerica's Leadership Development Program, she previously worked in a variety of positions with increasing responsibilities. Ms. Parchmon's previous positions include, Assistant Vice President, Enterprise Payments Strategy and First-Level Officer, Emerging Technologies and Payment Services. She began her career with the bank in July 2006 as a technical analyst.

Before joining Comerica, Ms. Parchmon worked for the Volkswagen Group (gedas USA) in Auburn Hills, Mich. During her nearly six year career with the organization, she worked in several technology areas. In her role as an infrastructure consultant, she worked with the e-marketing team to maintain and evolve Volkswagen of America's consumer facing websites. Ms. Parchmon was also a technical business analyst and had responsibility for partnering with business and technology groups to ensure web-based products met customer needs. Her career with gedas USA began in March 2001 as an intranet administrator.

Ms. Parchmon earned a Bachelor of Science degree with a major in management information systems from Oakland University in Rochester, Mich. She is also ITIL (Information Technology Infrastructure Library) certified in service management from the Information Systems Examinations Board.
